The BAC will issue Bidding Documents only to bidders declared by the BAC to be eligible. Paying the amount of Bid Documents equivalent to the sale prescribed under GPPB Res. No. 04-2012.

The City Government of Bago assumes no responsibility whatsoever to compensate or indemnify bidders for any expenses incurred in the preparation of their bids.

NOTE: Only those Bidders who able to purchase the Bidding Documents will be allowed to participate in the Pre-Bid Conference.
