AN APPROPRIATION ORDINANCE AUTHORIZING THE AUGMENTATION OF FUNDS IN THE AMOUNT OF ONE MILLION THREE HUNDRED THOUSAND TWO HUNDRED NINETY FIVE PESOS (P1,300,295.00) FOR THE ADDITIONAL TEN (10) DAYS MONETIZATION OF LEAVE CREDITS OF THE OFFICE OF THE CITY MAYOR. SAID AMOUNT MAY BE TAKEN FROM THE SAVINGS OF SALARIES/WAGES-REGULAR OF VARIOUS VACANT POSITIONS FOR THE MONTH OF AUGUST 2004 (P758,345.00), SAVINGS FOR OTHER PERSONNEL BENEFITS FOR THE MONTH OF JULY AND AUGUST 2004 (P261,950.00), SAVINGS FOR SALARIES/WAGES-CASUAL OF THE CITY ENGINEER'S OFFICE (P80,000.00) AND SAVINGS FOR SALARIES/WAGES-CONTRACTUAL OF THE BAGO CITY COLLEGE (P200,000.00), GENERAL FUND, ANNUAL BUDGET, CALENDAR YEAR 2004.

Be it ordained by the Sangguniang Panlungsod in session today, that:

SECTION 1. The Appropriation Ordinance authorizing the augmentation of funds in the amount of P1,300,295.00 is hereby approved. Said amount maybe taken from the savings of salaries/wages-regular of various vacant positions for the month of August 2004 (P758,345.00), savings for other personnel benefits for the month of July and August 2004 (P261,950.00), savings for Salaries/Wages-Casual of the City Engineer's Office (P80,000.00) and savings for Salaries/Wages-Contractual of the Bago City College (P200,000.00), General Fund, Annual Budget, Calendar Year 2004.

SECTION 2. This Appropriation Ordinance shall take effect upon its approval.
