SECTION 1. The Appropriation Ordinance authorizing the augmentation of funds in the amount of P 442,455.00 is hereby approved. Said amount may be taken from the salary savings and other personnel benefits of various vacant positions from March 16-31, 2005 of the General Fund, Annual Budget Calendar Year 2005.

SECTION 2. This request is in connection with the preparation of various documents such as, updating of Medium Term Development Plan for 2005-2010, preparation of Executive Legislative Agenda for 2005-2007, preparation of Local Poverty Reduction Action Plan, bid documents and preparation of other important documents needed to be prepared and submitted to various government agencies concerned.
