SECTION 1. The Appropriation Ordinance authorizing an additional appropriation in the amount of P1,500,000.00 is hereby approved. This should be taken as Supplemental Budget No. 32 of the General Fund for Calendar Year 2007.

SECTION 2. This Appropriation Ordinance shall be released in the following manner:

- a. First release - P250,000.00
- b. Next release - P125,000.00 and the following months thereafter until the amount of One Million Five Hundred Thousand Pesos (P1,500,000.00) is fully exhausted.

SECTION 3. This Appropriation Ordinance shall take effect upon its approval.
