AN ORDINANCE ADOPTING THE NEW SCHEDULE OF FEES AND OTHER CHARGES OF THE REVISED IMPLEMENTING RULES AND REGULATIONS OF THE NATIONAL BUILDING CODE OF THE PHILIPPINES (PD 1096).

Explanatory Note:

WHEREAS, in reference with the Revised and Updated Implementing Rules & Regulations of the National Building Code of the Philippines (PD 1096), the New Schedule of Fees and other charges of the Revised IRR of the same Presidential Decree was presented to this Sanggunian Panlungsod by Joenil B. Lavadia, City Engineer, for adoption and appropriate action.

WHEREAS, after a careful study of the said Schedule of Fees, this Sanggunian Panlungsod found it to be in order for enactment.

On motion of Sangguniang Member Nicholas M. Yulo, unanimously seconded by the Sanggunian Members present, the Sanggunian Panlungsod

Be it enacted by the Sanggunian Panlungsod, that:

Section 1. The New Schedule of Fees and Other Charges of the Revised Implementing Rules and Regulations of the National Building Code of the Philippines (PD 1096) which is hereto attached and are hereby adopted to form an integral part of the Local Revenue Code of the City of Bago.

Section 2. Sharing of Proceeds. – The proceeds from the order of payment issued by Acting Building Official, shall show breakdown of the total collection indicating the share of the City Government amounting to 80% & the 20% share of the National Government as prescribed in the above mentioned revised IRR of PD 1096.

Section 3. Repealing Clause. All Ordinances, rules and regulations, or parts thereof, provisions of which are in conflict with, or contrary to, the provisions of this Ordinance are hereby repealed, amended and modified accordingly.

Section 4. Effectivity. This Ordinance shall take effect after thirty (30) days from the date of its approval.




