ORDINANCE NO. 11 Series of 2006

AN ORDINANCE NAMING THE NEWLY-BUILT STRUCTURES AT BUENOS AIRES MOUNTAIN RESORT LOCATED AT BRGY. ILIJAN, BAGO CITY, AND CHARGING FEES FOR THE USE THEREOF.

Explanatory Note:

WHEREAS, Buenos Aires Mountain Resort after all these years has created a reputation worthy of its name as one of the premier resorts not only in the Province of Negros Occidental but all over the country as well;

WHEREAS, because of its growth and expansion more visitors are coming to enjoy the amenities it offers:

WHEREAS, because of the aforementioned reasons, the City Government of Bago deemed it wise to add more structures to accommodate the influx of visitors;

WHEREAS, the naming of its structures was a result of serious thought and deliberation on the part of its members, not forgetting the vital and visionary role of the late City Mayor Manuel Y. Torres, who made this project a reality.

On motion of Sanggunian Member Evangeline C. Magallanes, unanimously seconded by all members present, the Sanggunian;

Be it enacted by the Sangguniang Panlungsod of the City of Bago, that:

Section 1. One newly-built structure shall be named, MANUEL Y. TORRES SUITES.

Section 2. There shall be fees charged for the use thereof at P1,800.00 per room per day.

Section 3. The newly-built closed cottages shall be named and to be charged with the following fees:

1. Nasi-u (non- air conditioned)	-	P 800.00
2. Bagacay (non-air conditioned)	-	800.00
3. Ligawon (non-air conditioned)		800.00
4. Asaw-asaw (non-air conditioned)		800.00
5. Tabidiao (non-air conditioned)	-	800.00
6. Dalupya (air conditioned)	-	1,200.00
7. Kipot (air conditioned)	-	1,200.00
8. Sulyakon 1 (air conditioned)	-	1,200.00
9. Sulyakon 2 (air conditioned	-	1,200.00
10. Oro (air conditioned)	-	1,200.00

Section 4. All residents of Bago City including students and non-students could avail of the 10% discount on the above-mentioned facilities and all other facilities located therein;

Section 5. All other visitors not residents of Bago City could avail of the 20% discount during off-season. Off-season shall be considered as the months starting June to November of every year.

Section 6. Applicability Clause – The provisions of existing ordinances dealing on the same subject matter which are not in conflict with, or contrary to, the provisions of this Ordinance are hereby adopted and made an integral part of this Ordinance;

Section 7. Repealing Clause. All Ordinances, rules and regulations, or parts thereof, provisions of which are in conflict with, or contrary to, the provisions of this Ordinance are hereby repealed, amended and modified

Section 8. Effectivity. This Ordinance shall take effect thirty (30) days from the date of its approval.
