ORDINANCE NO. 15
Series of 2007

AN ORDINANCE IMPOSING ADDITIONAL CHARGES/FEEES IN THE ISSUANCE OF BUSINESS/MAYOR'S PERMIT TO COVER THE COST OF BUSINESS REGISTRATION PLATES AND RENEWAL OF STICKERS STARTING THE YEAR JANUARY 2008.

WHEREAS, the City ordinance of Bago as amended that all sectors, firms and other establishment doing business are required to secure Business/Mayor's permit to pay the necessary charges & fees based on the nature & capital of business engaged in;

WHEREAS, the Business/Mayor's permit are to be displayed by the store owners in the conspicuous places in their establishment for proper identification & proof of registration but since the permit are quite to small & placed inside the establishment which they cannot be easily seen by consuming public, hence the City Treasurer's Office is recommending the use of Business Registration Plates visibility especially during their inspection.

On motion of SP Member Ruben T. Torres, unanimously seconded by SP Members present, the Sanggunian Panlungsod

Be it ordained by the Sangguniang Panlungsod of the City of Bago, that:

Section 1. An additional amount of P500.00, P300.00 & P100.00 plus P50.00 for stickers shall be charged for large, medium & small business respectively & is hereby imposed & included among the charges/fees to be paid by owners of stores, firms & other establishment doing business in Bago City at the time they apply for previous Mayor's permit to cover the cost of business registration plated which will show the date, an area code, nature of business & establishment number among others.

Section 2. Business registration plates are valid for two (2) years from January, 2008 to December 2009. However, after expiration date the yearly renewal of the business/mayor's permit an additional amount of P50.00 will be charged to cover the cost of the business registration sticker.

Section 3. Replacement of dilapidated plates shall be determined by the City Treasurer's Office & the amount of P500.00, P300.00 & P100.00 shall be required before a duplicate plate is issued.

Section 4. Violation of this Ordinance shall be punished with the following penalties to wit:

- a. No display of the plate
Fine of P 500.00 1st offense
P1,000.00 2nd offense
P3,000.00 3rd offense plus revocation of Business Permit
- b. For displaying dilapidated plate as determined by the City Treasurer's Office
Fine of P 500.00 1st offense
P1,000.00 2nd offense
P3,000.00 3rd offense plus revocation of Business Permit
- c. For displaying a counterfeit plate
Fine of P5,000.00 plus revocation of Business Permit

Section 5. The City Treasurer's Office shall be responsible in the implementation of this ordinance. The preparation for design & printing of the registration plate and the monitoring thereon.

Section 6. Repealing Clause – All ordinances or any part thereof which are inconsistent with any provision of this ordinance are hereby repealed or modified accordingly.

Section 7. Effectivity Clause – This ordinance shall take effect on January 1, 2008.
