ORDINANCE NO. 08-03

AN ORDINANCE AMENDING ARTICLE V, SECTION 1 OF ORDINANCE NO. 144, SERIES OF 1980, ADOPTING THE GUIDELINES OF THE COMMISSION ON HIGHER EDUCATION (CHED) MEMORANDUM ORDER NO. 32, SERIES OF 2006, SECTION 5 ON THE GOVERNING BOARD OF A COLLEGE AND THE COMPOSITION OF ITS BOARD OF TRUSTEES.

EXPLANATORY NOTE:

WHEREAS, Ordinance No. 144, Series of 1980 created the Bago City Technical School with the purpose of providing training and tertiary education to the youth of Bago City and those of neighboring municipalities;

WHEREAS, Section 1, Article V of then Ordinance provides for the creation of a Board of Trustees which shall direct and manage the affairs of the Technical School. It also provides for the composition of the said Board with

- a) The City Mayor
- b) The Chairman of the Committee on Education of the Sanggunian
- c) The City Superintendent of Schools; and
- d) Four (4) prominent citizens to be appointed by the City Mayor;

WHEREAS, this Sanggunian Panlungsod passed Resolution No. 352, Series of 1988 amending Ordinance No. 144, Series of 1980, changing the name Bago City Technical School to Bago City College so as to reflect the enhancement of course offerings in the said institution;

WHEREAS, although Republic Act 7160, otherwise known as the Local Government Code of 1991 places post-secondary institutions and their operation under the approval of the Department of Education, Culture and Sports as stated in Section 458 (a) (5) (x), the passage of R.A. 7722 or the Higher Education Act created the CHED and has placed post-secondary education under their coverage;

WHEREAS, CHED Memorandum Order No. 32, Series of 2006 set the Policies, Standards and Guidelines on the Establishment and Operation of Local Colleges and Universities in Article V, Section 5 to wit:

"The Governing Board of a college or dalubhasaan shall be its Board of Trustees (BOT) with the following composition: Chairman, Local Chief Executive; Vice Chairman, President of the College; and seven (7) members composed of but not limited to, the President of the Faculty Association, President of the Supreme Student Council/Government, President of the alumni Association, Chairman of the Sanggunian Committee on Education, ALCU representative, Commission on Higher Education with rank not lower than Director and accredited business or industry sector. The CHED, ALCU, and accredited business or industry representative shall be appointed by the Board for a specific term provided, that the representatives of the faculty, student body and alumni are co-terminus with their respective terms of office."

WHEREAS, this Sanggunian hereby adopts the guidelines of the CHED Memorandum Order No. 32, Series of 2006, Section 5 on the Governing Board of a College and the composition of its Board of Trustees;

NOW THEREFORE, on motion of SP Member Bernadette M. Somcio, unanimously seconded by SP Members present, the Sanggunian

Be it ordained by the Sanggunian Panlungsod that Section 1 of article V of Ordinance No. 144, Series of 1980 is hereby amended and shall now read as follows.

" ARTICLE V – The Board of Trustees

Section 1. There shall be created a Board of Trustees which shall direct and manage the affairs of the Bago City College. The said Board shall be composed of the following members:


- a. Chairman - Local Chief Executive
 - b. Vice Chairman - President of the college
- Members:
- 1) President of the College Faculty Association
 - 2) President of the College Supreme Student Council/Government

- 3) President of the College Alumni Association
- 4) Chairman of the Sanggunian Committee on Education
- 5) ALCU Representative
- 6) Commission on Higher Education with rank not lower than Director; and
- 7) Accredited business or industry representative.


