ORDINANCE NO. 09-17

AN ORDINANCE AMENDING CERTAIN SECTION OF ORDINANCE NO. 09-03, PARTICULARLY CHARGES ON SURGICAL SUTURE.

Explanatory Note:

WHEREAS, there is a letter from Dr. Jesus Rey O. Pacilan requesting for an increase in their charges on suturing of wounds because of the significant increase in the prices of surgical suture;

WHEREAS, the said request has basis and meritorious;

NOW THEREFORE, upon motion of SP Member Rosario F. Gaudite, duly seconded by the SP Members Loreto N. Cauntoy, Victor B. Javellana, Bernadette M. Somcio, Jose Ermelo Z. Jara, Ruben T. Torres, the Sanggunian

Be it enacted by the Sanggunian Panlungsod, that,

SECTION 1. That Section 6F.01, Article F, Chapter VI, particularly the charges on surgical sutures shall now read as follows:

Sutures	
Vicryl	P 360.00
Silk 2-0	160.00
Silk 3-0	160.00
Silk 4-0	160.00

SECTION 2. Separability Clause. If for any reason or reasons, any part or provision of this Ordinance shall be held to be unconstitutional or invalid, other parts or provision thereof which are not affected shall continue to be in full force and effect.

SECTION 3. Repealing Clause. All Ordinances, rules and regulations, or parts thereof, which provisions are in conflict with, or contrary to, the provisions of this Ordinance are hereby repealed, amended and modified accordingly.

SECTION 4. Effectivity Clause. This Ordinance shall take effect upon approval or three days after publication in a newspaper of local circulation whichever comes later.
