**ORDINANCE NO. 17-07**

**AN AMENDATORY ORDINANCE AMENDING SECTION 6 OF ORDINANCE NO. 14-10, SERIES OF 2014.**

**Explanatory Note:**

**WHEREAS**, brought to the attention of the Sangguniang Panlungsod is a concern on the possible misconception to the provisions of Section 6 of Ordinance No. 14-10, Series of 2014 which may result to double claims as the same assistance is also extended by the barangays; and

**WHEREAS**, it is the consensus of the August body to amend the said provision to clarify the matter and ensure that the intents of the Ordinance is achieved.

**NOW, THEREFORE**, upon motion of SP Member Mae C. Javellana, duly seconded by SP Members Danilo U. Famoso, Ma. Josefa Y. Matti, Sergio T. Piansay, Andrew Martin Y. Torres, be it enacted by the Sanggunian Panlungsod, that:

**SECTION 1.** Section 6 of Ordinance No. 14-10, Series of 2014, is accordingly amended and shall now read as follows:

"SECTION 6. ROLE OF THE CITY MAYOR.

The Honorable City Mayor shall ensure the establishment of a VAWC Desk in every Barangay within their jurisdiction, and provide technical and financial assistance on the GAD appropriation or allocation of 5% of the Annual Budget for its operations and implementation to include honorarium and insurance of the VAWC Desk Officer. Provided, that assistance for honoraria and insurance shall be extended through counterparting or sharing scheme.

**SECTION 2.** Separability Clause. If for any reason or reasons, any part or provision of this Ordinance shall be held to be unconstitutional or invalid, other parts or provisions thereof which are not affected shall continue to be in full force and effect.

**SECTION 3.** Repealing Clause. All Ordinances, rules and regulations, or parts thereof, which provisions are in conflict with, or contrary to, the provisions of this Ordinance are hereby repealed, amended and modified accordingly.


**SECTION 4.** Effectivity Clause. This Ordinance shall take effect upon approval or after the same be published in full for three (3) consecutive days in a newspaper of local circulation, whichever comes later.
