ORDINANCE NO. 17-09

AN AMENDATORY ORDINANCE AMENDING SECTIONS 5, 9 AND 10 OF ORDINANCE NO. 17-04, OTHERWISE KNOWN AS THE ROAD SAFETY ORDINANCE OF BAGO CITY.

Explanatory Note:

WHEREAS, brought to the attention of the Sangguniang Panlungsod is a concern on the inclusion of additional acts that need to be regulated and the proportional allocation of the collected fines and the creation of a special account for collected fines to be used for road safety education, medical services and engineering; and

WHEREAS, it is the consensus of the August body to amend the said provisions to include the matter and ensure that the intents of the Ordinance is achieved.

NOW, THEREFORE, upon motion of SP Member Joszef Mark Dexter M. Somcio, duly seconded by SP Members Andrew Martin Y. Torres, Cleo F. Gaudite, Ma. Josefa Y. Matti, Danilo U. Famoso, be it enacted by the Sanggunian Panlungsod, that:

SECTION 1. Sections 5, 9 and 10 of Ordinance No. 17-04, are accordingly amended and shall now read as follows:

"Section 5. Prohibited Acts – The following acts are declared unlawful and prohibited by this Ordinance:

- a.- IXxxxxx
- m. Vending in road shoulders
- $n. \overline{X \times X \times X}$
- o. Driving without license
- p. <u>Driving an unregistered motor vehicle</u>
- q. <u>Driving without helmet</u>

Section 9. Implementation. The Traffic Management Unit of Bago City PNP and its other authorized groups or units shall serve as the implementing arm of this ordinance.

A road safety orientation conducted by the PNP Traffic Division shall be a requisite for the issuance/renewal of franchise and Mayor's Permit and Business License.

Section 10. Penalty Clause

Of the collected fine, 20% shall be given as incentives to the enforcers directly involved in the apprehension, 30% shall accrue to the General Fund, while the remaining 50% shall be deposited to a Special Account within the General Fund which shall be created by virtue of this Ordinance to be used for road safety education, medical services and engineering."

SECTION 2. Separability Clause. If for any reason or reasons, any part or provision of this Ordinance shall be held to be unconstitutional or invalid, other parts or provisions thereof which are not affected shall continue to be in full force and effect.

SECTION 3. Repealing Clause. All Ordinances, rules and regulations, or parts thereof, which provisions are in conflict with, or contrary to, the provisions of this Ordinance are hereby repealed, amended and modified accordingly.

SECTION 4. Effectivity Clause. This Ordinance shall take effect upon approval or after the same be published in full for three (3) consecutive days in a newspaper of local circulation, whichever comes later.
