RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN A MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND AMONG THE DEPARTMENT OF SOCIAL WELFARE AND DEVELOPMENT, THE CITY GOVERNMENT OF BAGO AND FEDERATION OF IRRIGATOR'S ASSOCIATION CENTRAL NEGROS-BAGO RIVER IRRIGATION SYSTEM FOR PROVIDING FUNDS FOR SUSTAINABLE LIVELIHOOD PROGRAMS OF THE CITY.
