**RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE CONTRACT OF SERVICES TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND MAGIC DISCO SOUND SYSTEM FOR THE FOLLOWING ACTIVITIES IN CONNECTION WITH THE 51ST CHARTER ANNIVERSARY OF THE CITY, AS FOLLOWS:**

- 1. RENTAL AND SERVICES OF LIGHTS, SOUNDS, AND TECHNICAL RIDER EQUIPMENT FOR PARTY AT THE PARK AT BANTAYAN PARK MAIN STAGE ON FEBRUARY 16, 2017.**
- 2. PROVIDE RENTAL AND SERVICES OF LIGHTS, SOUNDS, AND TECHNICAL RIDER EQUIPMENT FOR CULTURAL ACTIVITIES AT THE PARK AT BANTAYAN PARK MAIN STAGE ON FEBRUARY 15-19, 2017.**
- 3. RENTAL AND SERVICES OF LIGHTS, SOUNDS, AND TECHNICAL RIDER EQUIPMENT FOR PARTY AT THE PARK AT BANTAYAN PARK MAIN STAGE ON FEBRUARY 15, 17, 18 & 19, 2017.**
- 4. PROVIDE SERVICES OF 20 SETS LIVE BAND PERFORMERS FROM FEBRUARY 13 TO 19 AT BANTAYAN PARK – MAIN STAGE.**
- 5. PROVIDE RENTAL AND SERVICES OF POWER GENERATING SET AND LED WALL AND FOR PARTY AT THE PARK AT BANTAYAN PARK ON FEBRUARY 13-19, 2017.**
- 6. PROVIDE RENTAL AND SERVICES OF LIGHTS, SOUNDS, AND TECHNICAL RIDER EQUIPMENT FOR CULTURAL ACTIVITIES AT THE PARK AT BANTAYAN PARK – DENR STAGE ON FEBRUARY 15 TO 19, 2017.**
