EXPRESSING SINCEREST APPRECIATION AND COMMENDATION TO THE ASSISTANCE EXTENDED BY DENR-PENRO ANDRES T. UNTAL AND DENR-CENRO JOAN NATHANIEL F. GERANGAYA IN FACILITATING THE ISSUANCE OF SPECIAL PATENT IN FAVOR OF THE CITY GOVERNMENT OF BAGO OVER THE LAND AREA OF THE BANTAYAN PARK.

WHEREAS, the City Government of Bago is occupying, utilizing and developing a land accretion along Bago River with an area of one hundred fifty six thousand eight hundred sixty eight (156,868) square meters more or less which the local government named Bantayan Park;

WHEREAS, since 2006, the City Government had been processing the titling of the said parcel of land in its favor and sought the guidance of Eng'r. Joan Nathaniel F. Gerangaya, Community Environment and Natural Resources Officer (CENRO) and Forester Andres T. Untal, Provincial Environment and Natural Resources Officer (PENRO) of Negros Occidental, both of the Department of Environment and Natural Resources (DENR);

WHEREAS, both officials have extended extra-ordinary assistance worthy of emulation, that led to the speedy processing and issuance of a Special Patent in favor of the City Government, which document was formally turned-over to the Honorable City Mayor Nicholas M. Yulo and Vice Mayor Ramon D. Torres last February 13, 2017 on the occasion of the Opening Ceremony for the 51st Charter Anniversary Celebration; and

WHEREAS, the August Body is of the consensus to recognize and acknowledge the dedication and commitment extended by DENR CENRO Joan Nathaniel F. Gerangaya and DENR PENRO Andres T. Untal and their gargantuan contribution to the realization of development initiatives that had been and will be implemented in Bantayan Park.
