RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE CONTRACT OF LEASE TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND THE DEPARTMENT OF AGRARIAN REFORM, PROVINCE OF NEGROS OCCIDENTAL FOR THE LEASE OF OFFICE SPACE OWNED BY THE CITY GOVERNMENT OF BAGO SITUATED AT THE REGIONAL TRIAL COURT COMPOUND, BAGO CITY.
