RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN A MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND AMONG THE BUREAU OF SOILS AND WATER MANAGEMENT, DEPARTMENT OF AGRICULTURE REGIONAL FIELD OFFICE VI AND THE CITY GOVERNMENT OF BAGO FOR A JOINT COLLABORATION IN THE ESTABLISHMENT OF COMPOSTING FACILITY FOR BIODEGRADABLE WASTES.
