RESOLUTION REQUESTING THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) TO ALLOCATE FUNDS FOR THE IMPROVEMENT OF DRAINAGE ALONG ARANETA STREET FROM BARANGAY POBLACION TO BARANGAY SAMPINIT, THIS CITY.

WHEREAS, it has been noted that, during rainy season, the road section of Araneta Street, in front of Bago City Public Market is usually flooded due to inadequate drainage system;

WHEREAS, the said road section is a national road which repair and maintenance is within the jurisdiction of the Department of Public Works and Highways (DPWH)-District Engineering Office, Bago City; and

WHEREAS, after thorough deliberation, the August body is of the consensus to call the attention of the Department of Public Works and Highways (DPWH)-District Engineering Office on the matter;

NOW, THEREFORE, upon motion of SP Member Allan C. Galunan, unanimously seconded by SP Members present, the Sangguniang Panlungsod

RESOLVED, as it is hereby resolved, to request the Department of Public Works and Highways (DPWH) to allocate funds for the improvement of drainage along Araneta Street from Barangay Poblacion to Barangay Sampinit, this City.
