## **RESOLUTION NO. 17-167**

RESOLUTION FAVORABLY ENDORSING THE COMMERCIAL SAND AND GRAVEL PROJECT OF MR. ALBERTO B. MATTI LOCATED ALONG MARAGANDANG RIVER, BARANGAY DON JORGE L. ARANETA, THIS CITY, PROVIDED, THAT THE AREA APPLIED AS QUARRY SITE SHOULD BE LIMITED TO THAT PORTION NOT COVERED WITHIN THE 500 METERS RADIUS FROM ANY GOVERNMENT STRUCTURE.

**WHEREAS,** endorsed to this Honorable body, is the application of MR. ALBERTO B. MATTI, for a favorable endorsement of quarry project located along Maragandang River, Barangay Don Jorge L. Araneta, this City;

**WHEREAS,** this matter was referred to the Committee on Environmental Protection for an ocular inspection in which the City Engineering Office, after the conduct of technical assessment recommended that the area applied should be limited to that portion not covered within the 500 meters radius from the existing hanging bridge;

**WHEREAS,** the proponent, in an Undertaking submitted to the August body promised not to conduct quarrying activities within the 500 meters radius of the hanging bridge under pain of possible revocation of their permit;

**WHEREAS,** after a thorough deliberation on the matter, it is the consensus of this body to endorse the said permit provided that proponent will comply with the requirements set forth by the City Engineering Office and their submitted undertaking.

**NOW, THEREFORE,** upon motion of SP Member Allan C. Galunan, duly seconded by SP Members Carlos E. Mondia, Jorge Agustin A. Araneta, the Sanggunian

**RESOLVED,** as it is hereby resolved, to favorably endorse the Commercial Sand and Gravel Project of MR. ALBERTO B. MATTI, located along Maragandang River, Barangay Don Jorge L. Araneta, this City, provided, that the area applied as quarry site should be limited to that portion not covered within the 500 meters radius from any government structure.
