RESOLUTION NO. 17-174

RESOLUTION DENYING THE REQUEST FOR FAVORABLE ENDORSEMENT OF SAND AND GRAVEL QUARRY PROJECT OF MR. JORGE LUKE C. SIAN SITUATED AT PUROK MAINUSWAGON, BRGY. NAPOLES, BAGO CITY.

WHEREAS, in a letter dated May 23, 2017 from Mr. Vicente Mesias, SEMS/City ENRO-Designate, favorably endorsed by the Honorable City Mayor and addressed to this Honorable body, the documentary requirements of the application of MR. JORGE LUKE C. SIAN, for a favorable endorsement of quarry project located at Barangay Napoles, this City, and it was subsequently referred to the Committee on Environmental Protection for further study;

WHEREAS, on May 31, 2017, the Office of the Sangguniang Panlungsod received a letter-complaint signed by 105 persons who are allegedly residents of Purok Mainuswagon, Brgy. Napoles, Bago City against the application of Mr. Jorge Luke C. Sian stating that they are against the operation of the quarry project of the applicant for the reason that their purok might experience soil erosion and flooding when rainy season come;

WHEREAS, the Committee, then scheduled a series of committee meetings and ocular inspection to tackle the matter and came up with the recommendations that, among others, the applicant and Barangay should conduct another public consultation on the affected purok with resource persons from PEMO, DENR-EMB and MGB and for the August Body to seek clarification and legal opinion from the Provincial Legal Office on the interpretation of Section 3, Paragraph 3.2, B, 3, (j) of Provincial Tax Ordinance No. 11-001, Series of 2011 relative to the case of Mr. Sian;

WHEREAS, after thorough deliberation, the august body is of the consensus to adopt the recommendations of the Committee on Environmental Protection and deny the request for favorable endorsement of the subject quarry project without prejudice to its resubmission after corrective activities had been properly complied.

NOW, THEREFORE, upon motion of SP Member Allan C. Galunan, duly seconded by SP Members Cleo F. Gaudite, Jozsef Mark Dexter M. Somcio, Mae C. Javellana, the Sanggunian

RESOLVES, as it is hereby RESOLVED, to deny the request for favorable endorsement of the sand and gravel quarry project of Mr. Jorge Luke C. Sian situated at Purok Mainuswagon, Barangay Napoles, Bago City.
