**RESOLUTION NO. 17-175**

**RESOLUTION DENYING THE REQUEST FOR FAVORABLE ENDORSEMENT OF SAND AND GRAVEL QUARRY PROJECT OF MS. CARMEN MICHELLE C. VILLANUEVA SITUATED ALONG MA-AO RIVER, BARANGAY MA-AO, BAGO CITY.**

**WHEREAS**, in a letter dated June 5, 2017 from Mr. Vicente Mesias, SEMS/City ENRO-Designate, favorably endorsed by the Honorable City Mayor and addressed to this Honorable body, the documentary requirements of the application of MS. CARMEN MICHELLE C. VILLANUEVA, for a favorable endorsement of quarry project located at Barangay Ma-ao, this City, and it was subsequently referred to the Committee on Environmental Protection for further study;

**WHEREAS**, the Committee on Environmental Protection conducted a committee meeting and ocular inspection on June 21, 2017 and came up with the recommendation that the request for favorable endorsement of the said quarry project should be denied as its upper portion is situated about 70 meters away from a small dam owned by Mr. Sergio Hilado, Jr. and another dam which supplies the domestic and farm needs of the residents of Purok Ipil-Ipil (Hacienda Fermina), Brgy. Ma-ao is in the middle of the proposed quarry project, is the sole source of water irrigating not less than 150 hectares of rice, sugar and vegetable farms feeding not less than 120 households who are fully dependent on farming, and that a portion of the proposed quarry project is situated beside the main hacienda road which is the sole ingress and egress of the residents and products of the purok going to Brgy. Ma-ao proper, with which soil erosion is already noted;

**WHEREAS**, after thorough deliberation, the august body is of the consensus to adopt the recommendations of the Committee on Environmental Protection and deny the request for favorable endorsement of the subject quarry project considering its possible adverse impact on livelihood and infrastructure;

**NOW, THEREFORE**, upon motion of SP Member Allan C. Galunan, duly seconded by SP Members Cleo F. Gaudite, Jorge Agustin A. Araneta, Jozsef Mark Dexter M. Somcio, DAnilo U. Famoso, the Sanggunian

**RESOLVES** as it hereby RESOLVED to deny the request for favorable endorsement of the sand and gravel quarry project of Ms. Carmen Michelle C. Villanueva along Ma-ao River, Barangay Ma-ao, Bago City.
