RESOLUTION NO. 17-204

RESOLUTION REQUESTING THE CHIEF OF POLICE OF BAGO CITY PNP TO ASSIGN A DESIGNATED TRAFFIC INVESTIGATOR FROM MA-AO ComPAC TO ATTEND TO TRAFFIC INCIDENTS IN THE UPLAND BARANGAYS.

WHEREAS, it has come to the attention of the August body that investigation of traffic incidents in the upland barangays is still being conducted by an investigator coming from the Bago City PNP Headquarters despite the presence of Ma-ao Community Police Assistant Center (ComPAC) with police personnel who are trained to conduct investigation of such cases;

WHEREAS, it is the profound intention of the August body to encourage speedy response and conduct of investigation which at present is not possible given the multitude of traffic accidents viz-a-viz the assigned traffic investigator;

NOW, THEREFORE, upon motion of SP Member Sergio T. Piansay, duly seconded by SP Member Jozsef Mark Dexter M. Somcio, the Sangguniang Panlungsod

RESOLVES, as it is hereby resolved, to request the Chief of Police of Bago City PNP to assign a designated Traffic Investigator from Ma-ao ComPAC to attend to traffic incidents in the upland barangays.
