RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE SISTERHOOD AGREEMENT BETWEEN THE CITY GOVERNMENT OF BAGO AND CITY GOVERNMENT OF SILAY, NEGROS OCCIDENTAL TO ESTABLISH LINKAGES/NETWORKING OF BOTH LGU'S FOR DISASTER RISK REDUCTION AND EMERGENCY RESPONSE PURPOSES.
