**RESOLUTION REQUESTING THE DPWH 4TH DISTRICT ENGINEERING OFFICE TO INITIATE PROCEEDINGS FOR THE CONVERSION OF THE FOLLOWING ROAD SECTIONS FROM BARANGAY ROAD TO NATIONAL SECONDARY ROAD:**

- A. DON JORGE ARANETA-AYUNGON ROAD (CONNECTS BAGO-MA-AO-MAILUM-MAMBUCAL-CANLAON NATIONAL SECONDARY ROAD TO LA CARLOTA CITY)**
- B. BAGO-NAPOLES-MALINGIN-SAN JUAN DEL MONTE ROAD (CONNECTS BACOLOD-SOUTH-PRIMARY ROAD TO JCT. MURCIA-CANSILAYAN DAM SITE-ABUANAN-BAGO ROAD)**
- C. JCT. SUM-AG-ABUANAN-FELISA ROAD (CONNECTS SUM-AG-ABUANAN NATIONAL SECONDARY ROAD TO BACOLOD CITY).**

**WHEREAS**, in an endorsement letter dated August 14, 2017 from the Honorable City Mayor, addressed to this body, concerning the request of Engr. Joenil B. Lavadia, City Engineer, this City, to pass a resolution requesting the DPWH 4th District Engineering Office to initiate proceedings for the conversion of the following road sections from barangay road to national secondary road:

- a. Don Jorge Araneta-Ayungon Road (connects Bago-Ma-ao-Mailum-Mambucal- Canlaon National Secondary Road to La Carlota City)
- b. Bago-Napoles-Malingin-San Juan del Monte Road (connects Bacolod-South-Primary Road to Jct. Murcia-Cansilayan Dam Site-Abuanan-Bago Road)
- c. Jct. Sum-ag-Abuanan-Felisa Road (connects Sum-ag-Abuanan National Secondary Road to Bacolod City);
