MONICA VILLAGE, SITUATED AT BARANGAY TALOC, THIS CITY, CONTAINING AN AREA OF TWENTY NINE THOUSAND EIGHT HUNDRED FIFTY FOUR (29,854) SQUARE METERS, CONTAINING 162 SALEABLE LOTS.
