## **RESOLUTION NO. 17-225**

RESOLUTION AUTHORIZING THE HOLDING OF COCKFIGHTING ACTIVITIES OF THE DIFFERENT PUROKS/BARANGAYS OF THIS CITY, IN CONNECTION WITH THEIR RESPECTIVE ANNUAL PUROK/BARANGAY CELEBRATION, TO WIT:

AUGUST 26-27, 2017 PUROK SAN JOSE, BARANGAY CALUMANGAN SEPTEMBER 22-23, 2017 PUROK GAWAY-GAWAY, BARANGAY PACOL PUROK RIVERSIDE, BARANGAY MA-AO

**WHEREAS**, presented in session assembled are requests for the holding of cockfighting activities of the different puroks/barangays of this city;

**WHEREAS**, peace and order must be maintained during said activity by the organizer in coordination with the Bago City Police Station;

**WHEREAS**, existing laws and regulations require that cockfighting activities relative to the celebration of purok, barangay and city local fiesta must be conducted in a duly licensed/designated cockpit of the local government;

**WHEREAS**, the Sangguniang Panlungsod designated Bantayan Park Multi-purpose Center as the official venue for the conduct of cockfighting activities relative to the purok, barangay and city celebration of their respective local fiesta;

**WHEREAS,** after deliberation on the matter, it is the consensus of this assembly to approve the same subject to existing laws, rules and regulations, particularly that the same should be conducted at Bantayan Park Multi-purpose Center being the designated venue for said activity in the City;

**NOW, THEREFORE,** upon motion of SP Member Jorge Agustin A. Araneta, duly seconded by SP Members Carlos E. Mondia, Andrew Martin Y. Torres, the Sangguniang Panlungsod

**RESOLVED,** as it is hereby resolved, to authorize the holding of cockfighting activities of the mentioned puroks/barangays and city fiesta of this city, in connection with their respective annual purok/barangay celebration.
