RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN A MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND EARLY CHILDHOOD CARE AND DEVELOPMENT (ECCD) COUNCIL FOR THE ESTABLISHMENT AND CONSTRUCTION OF A FULLY-FURNISHED AND FULLY-EQUIPPED NATIONAL CHILD DEVELOPMENT CENTER (NCDC) WITHIN THE CITY WITH AN ESTIMATED PROJECT COST OF TWO MILLION THREE HUNDRED THOUSAND PESOS (PHP 2,300,000.00) FUNDED BY THE ECCD COUNCIL.

WHEREAS, letter dated September 26, 2017 from the Honorable City Mayor, respectfully referred to this Honorable Body for a passage of a resolution authorizing him to sign for and in behalf of the City of Bago in a Memorandum of Agreement to be executed by and between the City Government of Bago and Early Childhood Care and Development (ECCD) Council for the establishment and construction of a fully-furnished and fully-equipped National Child Development Center (NCDC) within the City with an estimated project cost of Two Million Three Hundred Thousand Pesos (Php 2,300,000.00) funded by the ECCD Council;
