**RESOLUTION REALIGNING THE AMOUNT OF ONE HUNDRED FIFTY THOUSAND (P150,000.00) PESOS FROM THE PROGRAM: ESTABLISHMENT OF WOMEN AND CHILD PROTECTION UNIT AT BAGO CITY HOSPITAL TO OPERATION OF BAGO CITY CRISIS CENTER FOR WOMEN AND CHILDREN UNDER THE GENDER AND DEVELOPMENT (GAD) FUND CY 2017.**

**WHEREAS**, in an endorsement letter dated October 3, 2017 from the Honorable City Mayor, addressed to this body, concerning the request of Mrs. Ma. Elena Y. Millevo, CSWDO, this City, that the amount of One Hundred Fifty Thousand (P150,000.00) pesos only be realigned from the program: Establishment of Women and Child Protection Unit at Bago City Hospital to Operation of Bago City Crisis Center for Women and Children under the Gender and Development (GAD) Fund CY 2017;

**WHEREAS**, this amount is intended to cover for the honorarium of social workers and social service providers assigned at the center for the remaining period of the year; due to mischarge of honoraria for the two (2) social workers assigned at the hospital for the past 5 months (March-July, 2017) to the Crises Center for Women and Children;

**WHEREAS**, after a thorough deliberation, the members of this Honorable Body is of the consensus to grant said request;
