RESOLUTION NO. 17-325

RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO ACCEPT THE PROPOSAL OF PUROK BALINGHOY HOMEOWNER'S ASSOCIATION TO PURCHASE LOT NO. 217-B-1-B, UNDER TCT NO. T-33524 WITH THE TOTAL AMOUNT OF FOUR MILLION ONE HUNDRED EIGHTY THREE THOUSAND THREE HUNDRED PESOS (P4,183,300.00).

WHEREAS, letter dated December 5, 2017 from the Honorable City Mayor, respectfully referred to this Honorable Body for a passage of a resolution authorizing him to accept the proposal of Purok Balinghoy Homeowner's Association to purchase Lot No. 217-B-1-B, under TCT No. T-33524 with the total amount of Four Million One Hundred Eighty Three Thousand Three Hundred Pesos (P4,183,300.00);

WHEREAS, Resolution No. 17-041 was passed authorizing the undersigned to sign in the intent to sell on all the relocation sites to the organized community associations; and on the process of providing security of tenure to the actual occupants through the Community Mortgage Program (CMP) of the Social Housing Finance Corporation (SHFC), the Purok Balinghoy Homeowner's Association submitted their proposal dated October 23, 2017 to purchase the property of the City Government under CMP;

WHEREAS, after a thorough deliberation, the members of this Honorable Body is of the consensus to favorably act on said request;

NOW, THEREFORE, upon motion of SP Member Jorge Agustin A. Araneta, duly seconded by SP Members Carlos E. Mondia, Cleo F. Gaudite, Danilo U. Famoso, Sergio T. Piansay, the Sangguniang Panlungsod
