**RESOLUTION GIVING AUTHORITY TO THE HONORABLE CITY MAYOR TO GRANT THE EXCELLENT PERFORMANCE INCENTIVES (EPI) TO CITY OFFICIALS AND EMPLOYEES IN THE AMOUNT OF TWENTY FIVE THOUSAND PESOS (P25,000.00) EACH, TO BE TAKEN FROM ACCUMULATED SAVINGS FROM PERSONAL SERVICES (PS) OF 2017.**

**WHEREAS**, Indorsement letter dated December 20, 2017 from the Honorable City Mayor, respectfully referred to this Honorable body, the request to conduct a Special Session on December 21, 2017 to tackle the request for a passage of a resolution giving authority to the Honorable City Mayor to grant the Excellent Performance Incentives (EPI) to officials and employees in the amount of Twenty Five Thousand Pesos (P25,000.00) each to be taken from accumulated savings from Personal Services (PS) of 2017;

**WHEREAS**, as mandated by law, it is the Sangguniang Panlungsod which has the power to *“Determine the positions and salaries, wages, allowances and other emoluments and benefits paid wholly or mainly from city funds...” (IRR to R.A. 7160, Art. 99 (a) (1) (viii))*;
