**ORDINANCE NO. 18-06**

**AN AMENDATORY ORDINANCE AMENDING SECTION 3 OF ORDINANCE NO. 09-07, SERIES OF 2009, AS PREVIOUSLY AMENDED BY SECTION 1 OF ORDINANCE NO. 14-12, SERIES OF 2014.**

**Explanatory Note:**

**WHEREAS**, Calendar Year 2018 is a general revision year mandated by Section 219 of R.A. 7160, otherwise known as the Local Government Code of 1991;

**WHEREAS**, it is the mandate of the Bago City Assessor's Office to conduct a General Revision of Real Property Assessments once every three years;

**NOW, THEREFORE**, upon motion of SP Member Cleo F. Gaudite, duly seconded by SP Members Jorge Agustin A. Araneta, Carlos E. Mondia, be it enacted by the Sanggunian Panlungsod, that:

**SECTION 1.** Section 3 of Ordinance No. 09-07, Series of 2009, is accordingly amended and shall now read as follows:

"Section 3. - That the Assessment Level of all classes of land effective Calendar Year 2018-2020 shall be as follows:

(1) On Lands:

<u>Kind</u>	<u>Assessment Level</u>
Residential	<u>10%</u>
Agricultural	<u>23%</u>
Commercial	<u>24%</u>
Industrial	<u>24%</u>
Mineral	<u>21%</u>
Timber Land	<u>21%</u>


**SECTION 2.** Separability Clause. If for any reason or reasons, any part or provision of this Ordinance shall be held to be unconstitutional or invalid, other parts or provisions thereof which are not affected shall continue to be in full force and effect.

**SECTION 3.** Repealing Clause. All Ordinances, rules and regulations, or parts thereof, which provisions are in conflict with, or contrary to, the provisions of this Ordinance are hereby repealed, amended and modified accordingly.


**SECTION 4.** Effectivity Clause. This Ordinance shall take effect upon approval or after the same be published in full for three (3) consecutive days in a newspaper of local circulation, whichever comes later.
