ORDINANCE NO. 18-08

AN ORDINANCE AUTHORIZING THE CITY TREASURER TO CHARGE AGAINST CURRENT APPROPRIATION FOR TRAVELLING EXPENSES-LOCAL OF THE PEACE AND ORDER PROGRAM (PNP-BAGO CITY) THE AMOUNT OF THIRTY ONE THOUSAND FIVE HUNDRED TWENTY EIGHT PESOS (P31,528.00), REPRESENTING THE TRAVELLING EXPENSES TO BACOLOD CITY OF SPO1 COLIE T. DIONELA AND SPO1 SALDY V. MAGDALERA, ATTENDING THE OPENING OF FIELD TRAINING OFFICERS DEVELOPMENT PROGRAM AND ORIENTATION OF 299 PSFTP CLASS MASIKLAB 2016-02 AND FTO'S LAST MAY 10-25, 2017 AND AUGUST 18, 2017 TO FEBRUARY 1, 2018.

Be it ordained by the Sangguniang Panlungsod in session assembled, that:

SECTION 1. The authority of the City Treasurer to Charge against Current Appropriation for Travelling Expenses-Local of the Peace and Order Program (PNP-Bago City) the amount of Thirty One Thousand Five Hundred Twenty Eight Pesos (P31,528.00), representing the Travelling Expenses to Bacolod City of SPO1 Colie T. Dionela and SPO1 Saldy V. Magdalera, attending the Opening of Field Training Officers Development Program and Orientation of 299 PSFTP Class Masiklab 2016-02 and FTO's last May 10-25, 2017 and August 18, 2017 to February 1, 2018, is hereby approved.


