RESOLUTION REQUESTING THE DENR-CENRO, BAGO CITY FOR THE APPROVAL OF THE PROPOSED EARTH-BALLING AND TRANSPLANT EXISTING FULL-GROWN MANGROVE TREES LOCATED NEAR THE RETAINING WALL OF BANTAYAN PARK, BARANGAY POBLACION, BAGO CITY TO SITIO BATAD, BARANGAY SAMPINIT, WHICH IS IDENTIFIED AS A MANGROVE RESERVE.

WHEREAS, in an indorsement letter dated January 10, 2018 from the Honorable City Mayor, respectfully referred to this Honorable body, the request of Engr. Joenil B. Lavadia, City Engineer, this City, for the passage of a Resolution requesting the DENR-CENRO, Bago City for the approval of the proposed earth-balling and transplant existing full-grown mangrove trees located near the retaining wall of Bantayan Park, Barangay Poblacion, Bago City to Sitio Batad, Barangay Sampinit which is identified as a Mangrove Reserve;

WHEREAS, the aforementioned mangrove trees naturally propagate itself rapidly and if left unabated may obstruct the free flow of water along Bago River which may consequently cause flooding at the park and its surrounding low-lying areas;

WHEREAS, after a thorough deliberation on the matter, it was the consensus of this August body to grant said request;

NOW, THEREFORE, upon motion of SP Member Allan C. Galunan, duly seconded by SP Members Sergio T. Piansay, Ma. Femmy A. Martir, Jorge Agustin A. Araneta, the Sangguniang Panlungsod
