## **RESOLUTION NO. 18-057**

RESOLUTION REQUESTING THE OFFICE OF THE GOVERNOR OF NEGROS OCCIDENTAL TO INCLUDE THE FAVORABLE RESOLUTION FROM THE SANNGUNIANG PANLUNGSOD AMONG THE REQUIREMENTS IN THE APPLICATION FOR SPECIAL PERMIT TO QUARRY SAND AND GRAVEL MATERIALS WITHIN THE TERRITORIAL JURISDICTION OF THIS CITY.

**WHEREAS**, existing policy of the Provincial Government of Negros Occidental relative to the application for special permit to quarry sand and gravel materials does not include a favorable Sangguniang Panlungsod Resolution, which sometimes result to misinformation, conflicts and issues at the local level;

**WHEREAS**, pursuant to the general welfare clause of the Local Government Code, local officials are mandated to exercise the powers expressly mandated, necessary implied therefrom, appropriate or incidental for its efficient and effective governance, particularly in their duty to enhance the right of the people to a balanced ecology;

**WHEREAS**, it is the consensus of this August Body that extractive activities such as quarrying of sand and gravel materials, regardless of volume or duration, must at all times be properly assessed, scrutinized, deliberated upon and favorably endorsed at the City level, prior to consideration by the Provincial Government;

**NOW, THEREFORE,** upon motion of SP Member Allan C. Galunan, duly seconded by SP Members Jozsef Mark Dexter M. Somcio, Carlos E. Mondia, Jorge Agustin A. Araneta, Danilo U. Famoso, the Sanggunian

**RESOLVES**, as it is hereby resolved, to request the Office of the Governor of Negros Occidental to include the favorable Sanggunaing Panlungsod Resolution among the requirements in the application for special permit to quarry sand and gravel materials within the territorial jurisdiction of this City.
