RESOLUTION APPROVING RESOLUTION NO. 2018-02 OF THE CITY DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL, THIS CITY, ENTITLED: "RESOLUTION AUTHORIZING THE PROGRAMMING OF THE UNEXPENDED BALANCE OF THE SPECIAL TRUST FUND FOR CY 2017 IN THE AMOUNT OF NINETEEN MILLION FOUR HUNDRED THIRTY FOUR THOUSAND TWO HUNDRED SEVENTY SIX PESOS AND 62/100 CENTAVOS (PHP19,434,276.62) FOR THE FOLLOWING PROGRAMS AND PROJECTS AS REFLECTED IN THE SUPPLEMENTAL SPECIAL TRUST FUND-ANNUAL INVESTMENT PLAN (STF-AIP) FOR CY 2018 OF THE CITY DISASTER RISK REDUCTION AND MANAGEMENT COUNCIL".
