RESOLUTION DIRECTING CENECO, GLOBE TELECOM AND PLDT TO RELOCATE AND REPAIR RUINOUS UTILITY POLES AND LINES WHICH POSE DANGER TO MOTORISTS AND THE GENERAL PUBLIC.

WHEREAS, the ruinous utility poles and electrical/communication lines are structurally unsafe and dangerous to human life and constitute hazard to the safety and welfare of motorists and the general public because of inadequate maintenance, dilapidation, abandonment and obsolescence;

WHEREAS, they are likely to fall and prone to possible collapse and thereby injure persons or damage to property;

WHEREAS, after thorough deliberation, it is the consensus of the August body to call the attention of the CENECO, GLOBE TELECOM and PLDT, to initiate appropriate action on the matter.
