**WHEREAS**, the City of Bago, Negros Occidental has an existing Bago City Health Office located in Gonzaga Street, Barangay Poblacion, this City, that serves as an entire catchment areas;

**WHEREAS**, the Local Government Unit with the assistance from the Department of Health through the Health Facility Enhancement Program (HFEP) Projects for the Upgrading of RHU as Birthing Facility to improve the preventive health care services and attainment of the Universal Health Care (UHC) or “*Kalusugan Pangkalahatan*” in ensuring that all the constituents of the City of Bago especially the disadvantaged group in the spirit of solidarity, have equitable access to affordable health care;
