RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE DEED OF DONATION TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND BACHELOR EXPRESS, INCORPORATED FOR THE DONATION OF ONE (1) UNIT NON-AIRCON BUS AMOUNTING TO TWO MILLION FOUR HUNDRED THOUSAND PESOS (P2,400,000.00) TO THE CITY OF BAGO.

WHEREAS, letter dated April 2, 2018 from the Honorable City Mayor, respectfully referred to this Honorable Body for a passage of a resolution authorizing the Honorable City Mayor to sign for and in behalf of the City of Bago in the Deed of Donation to be executed by and between the City Government of Bago and Bachelor Express, Incorporated for the donation of One (1) Unit non-aircon bus amounting to Two Million Four Hundred Thousand Pesos (P2,400,000.00) to the City of Bago;
