**RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN A MEMORANDUM OF AGREEMENT TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND BUREAU OF FISHERIES AND AQUATIC RESOURCES, REGIONAL OFFICE 6 FOR THE CONSTRUCTION OF FIVE (5) UNITS STAND ALONE FISH STALLS IN THE CITY OF BAGO.**

**WHEREAS**, letter dated April 2, 2018 from the Honorable City Mayor, respectfully referred to this Honorable Body for a passage of a resolution authorizing the Honorable City Mayor to sign for and in behalf of the City of Bago in a Memorandum of Agreement to be executed by and between the City Government of Bago and Bureau of Fisheries and Aquatic Resources, Regional Office 6 for the construction of five (5) Units Stand Alone Fish Stalls in the City of Bago;
