RESOLUTION APPROVING THE SUBDIVISION PLAN OF MASBEL LOT 64 RESETTLEMENT SITE, OWNED BY THE CITY GOVERNMENT OF BAGO, SITUATED AT BARANGAY LAG-ASAN, THIS CITY, CONTAINING AN AREA OF EIGHT THOUSAND EIGHT HUNDRED SIXTY ONE (8,861) SQUARE METERS INTO SEVENTY ONE (71) RESIDENTIAL LOTS.

WHEREAS, in an endorsement letter dated April 3, 2018 from the Honorable City Mayor, addressed to this body, concerning the request of Engr. Ernie Earl D.
