RESOLUTION APPROVING THE SUBDIVISION PLAN OF BARANGAY PACOL RESETTLEMENT SITE, OWNED BY THE CITY GOVERNMENT OF BAGO, SITUATED AT BARANGAY PACOL, THIS CITY, CONTAINING AN AREA OF TWENTY FOUR THOUSAND SEVEN HUNDRED THIRTY FIVE (24,735) SQUARE METERS INTO ONE HUNDRED FIFTY SIX (156) RESIDENTIAL LOTS.

WHEREAS, in an endorsement letter dated April 3, 2018 from the Honorable City Mayor, addressed to this body, concerning the request of Engr. Ernie Earl D. Baylon, Public Services Officer IV/Zoning Officer IV-Designate, for approval, the Subdivision Plan of Barangay Pacol Resettlement Site, owned by the City Government of Bago, situated at Barangay Pacol, this City, containing an area of Twenty Four Thousand Seven Hundred Thirty Five (24,735) Square Meters into One Hundred Fifty Six (156) residential lots; and
