RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO NEGOTIATE AND SIGN FOR AND IN BEHALF OF THE CITY OF BAGO FOR THE PURCHASE OF A PARCEL OF LAND OWNED BY MARIA LUISA T. SOLIS LOCATED AT BAGO CITY, NEGROS OCCIDENTAL, CONTAINING AN AREA OF MORE OR LESS 8,635 SQUARE METERS COVERED BY TCT NO. T-37432 FOR BARANGAY ROAD USE.
