RESOLUTION DENYING ACCEPTANCE OF THE OFFER BY DONATION OF THE MASANGKAY FAMILY OF A ROAD LOT AT BARANGAY PACOL, THIS CITY

WHEREAS, a letter of endorsement from the Office of the City Mayor transmitted to this level a communication from Ms. Trinidad I. Masangkay and Ms. Marjorie I. Masangkay, both owners of a road lot which they intended to donate to the local government and the communication from Eng.r. Joenil B. Lavadia reporting to the Office of the City Mayor that the subject road lot is an isolated private property that does not connect with the Jct. Bago-Ma-ao-Pacol Road;

WHEREAS, as mandated by R.A. 7160, otherwise known as the Local Government Code, the local chief executive, upon authority from the Sangguniang Panlungsod, may negotiate and secure grants and donations in kind;

WHEREAS, this August Body among others, considers the criteria that a donation should be favorable to the local government, aligned with the city's development plan and will serve the general public before a requisite authority is granted to the City Mayor to accept the same;

WHEREAS, as per findings by the City Engineering Office that the subject road lot is an isolated private property and does not connect with the Jct. Bago-Ma-ao-Pacol Road, it is established that the said road lot subject of the offer for donation falls short of the criteria, hence, the August Body is of the consensus to deny acceptance of said donation.

NOW, THEREFORE, upon motion of SP Member Carlos E. Mondia, duly seconded by SP Member Jorge Agustin A. Araneta, the Sanggunian

RESOLVES, as it is hereby resolved, to deny acceptance of the offer for donation by the Masangkay Family of a road lot at Barangay Pacol, this City
