**RESOLUTION NO. 18-175**

**RESOLUTION INTERPOSING NO OBJECTION ON THE CUTTING/REMOVAL OF THE AFFECTED TREES WITHIN THE ROAD RIGHTS OF WAY LIMITS IN RELATION TO THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS (DPWH) CONSTRUCTION OF BAGO CITY-BACOLOD CITY BY-PASS ROAD (TABUNAN-CABUG SECTION) INCLUDING THE BRIDGE.**

**WHEREAS**, the Department of Public Works and Highways (DPWH) will be implementing the CY 2018 project, the construction of Bago City-Bacolod City By-Pass Road (Tabunan-Cabug Section) including the Bridge, within the City;

**WHEREAS**, trees of various species within the road right-of-way limits will be affected by the said project and need to be cut to give way to the construction activities;

**WHEREAS**, the DPWH is currently processing the application for the issuance of the Tree Cutting Permit and Environmental Compliance Certificate (ECC) for the implementation of the said project;

**WHEREAS**, one of the requirements of the Department of Environment and Natural Resources (DENR) for the issuance of tree cutting permit is the Sangguniang Panlungsod Resolution interposing no objection on the cutting/removal of the affected trees within the road right of way limits;

**WHEREAS**, after a thorough deliberation, the members of this Honorable Body is of the consensus to grant said request, provided that consultation is conducted with stakeholders;

**NOW, THEREFORE**, upon motion of SP Member Carlos E. Mondia, duly seconded by SP Member Andrew Martin Y. Torres, the Sangguniang Panlungsod

**RESOLVES**, as it is hereby resolved, to interpose no objection on the cutting/removal of the affected trees within the road right of way limits in relation to the Department of Public Works and Highways (DPWH) construction of Bago City-Bacolod City By-Pass Road (Tabunan-Cabug Section) including the Bridge.
