RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO NEGOTIATE AND PURCHASE FOR AND IN BEHALF OF THE CITY GOVERNMENT OF BAGO WITH RESPECT TO THE OFFER TO SELL OF GILA MORADA AND HEIRS OF CATALINA JALANDONI FOR A PARCEL OF LAND COVERED UNDER LOT NO. 857-C-2-D-1-B, TITLE NO. 093-2016000394 WITH AN AREA OF EIGHTY FIVE THOUSAND TWO HUNDRED NINETEEN (85,219 SQ. M.) LOCATED AT MA. MORENA, BARANGAY CALUMANGAN, BAGO CITY.
