RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO NEGOTIATE AND PURCHASE FOR AND IN BEHALF OF THE CITY GOVERNMENT OF BAGO WITH THE HEIRS OF DAVID ALCANTARA WITH RESPECT TO THEIR OFFER TO SELL THE PROPERTY OF THE LATE DAVID ALCANTARA COVERED UNDER LOT NO. 134, TITLE NO. 8078 WITH AN AREA OF FOUR THOUSAND THREE HUNDRED FOURTEEN (4,314 SQ. M.) LOCATED AT PUROK LIMBO, BARANGAY POBLACION, BAGO CITY.
