RESOLUTION APPROVING RESOLUTION NO. 7, SERIES OF 2018 OF THE CITY DEVELOPMENT COUNCIL-EXECUTIVE COMMITTEE, BAGO CITY, ENTITLED: "RESOLUTION APPROVING THE PROGRAMMING OF TWENTY MILLION PESOS (PHP20,000,000.00) FROM THE CY 2018 UNDERESTIMATED 20& IRA DEVELOPMENT FUND FOR THE FOLLOWING PROJECTS: 91) CONSTRUCTION/REHABILITATION OF LGU-OWNED POTABLE WATER SUPPLY SYSTEM- PHP5,000,000.00, (2) CONSTRUCTION OR REHABILITATION OF LOCAL ROADS OR BRIDGES, INCLUDING PURCHASE OF APPROPRIATE ENGINEERING EQUIPMENT SUCH AS DUMP TRUCKS, GRADERS AND PAYLOADERS-PHP12,000,000.00, AND (3) OTHER PROJECTS THAT CONTRIBUTES TO ECONOMIC DEVELOPMENT-PHP3,000,000.00".
