RESOLUTION AMENDING RESOLUTION NO. 18-096 TO READ AS FOLLOWS: "RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY OF BAGO IN THE DEED OF DONATION TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND VIRGO MARINE CORPORATION IN THE DONATION OF ROAD LOTS, ALLEYS AND OPEN SPACES AT MARINA BAY HOMES LOCATED AT BARANGAY LAG-ASAN, BAGO CITY.
