**RESOLUTION ADOPTING THE FISHERIES ADMINISTRATIVE ORDER NO. 246-1, SERIES OF 2018.**

**WHEREAS**, Fisheries Administrative Order (FAO) No. 246 is a regulation that seeks the nationwide ban of hulbot-hulbot and buli buli fishing in the country;

**WHEREAS**, there is a new Order which is the Fisheries Administrative Order No. 246-1 which amended FAO No. 246 on the banning of the operation of Danish Seine and Modified Danish Seine in Philippine Waters;

**WHEREAS**, it shall be unlawful for any person to operate in our municipal waters, commercial fishing boats using Danish Seine or Modified Danish Seine in catching fish;

**WHEREAS**, after a thorough deliberation, the members of this Honorable Body is of the consensus to adopt the same in our City.

**NOW, THEREFORE**, upon motion of SP Member Ma. Femmy A. Martir, duly seconded by SP Members Carlos E. Mondia and Danilo U. Famoso, the Sanggunian Panlungsod
