RESOLUTION DENYING THE REQUEST FOR FAVORABLE ENDORSEMENT OF THE COMMERCIALSAND AND GRAVEL QUARRY PROJECT OF MS. BELINDA A. MONTEMAYOR SITUATED AT BARANGAY MAILUM, BAGO CITY.

WHEREAS, in a letter dated May 17, 2018 from Mr. Vicente Mesias, SEMS/City ENRO-Designate, favorably endorsed by the Honorable City Mayor and addressed to this Honorable body, the documentary requirements of the application of MS. BELINDA A. MONTEMAYOR, for a favorable endorsement of quarry project located at Barangay Mailum, this City, and it was subsequently referred to the Committee on Environmental Protection for further study;

WHEREAS, the Committee on Environmental Protection conducted ocular inspection and several hearings relative to the application considering its implications to the natural environment and the operation of the Buenos Aires Mountain Resort on one hand and the economic benefits it may bring about to the community on the other;

WHEREAS, the Committee in its Report presented to the plenary had considered the primacy of protecting the natural heritage and the economic and tourism values it offer to Buenos Aires Mountain Resort as the source of pride and honor for Bagonhons;
