**RESOLUTION AUTHORIZING THE HONORABLE CITY MAYOR TO SIGN FOR AND IN BEHALF OF THE CITY GOVERNMENT OF BAGO IN THE DEED OF DONATION TO BE EXECUTED BY AND BETWEEN THE CITY GOVERNMENT OF BAGO AND THE DEPARTMENT OF EDUCATION (DEPED), BAGO CITY, FOR A PARCEL OF LOT COVERED UNDER TCT NO. T-16828 SITUATED AT BARANGAY ATIPULUAN, THIS CITY, CONTAINING AN AREA OF FIVE THOUSAND (5,000) SQUARE METERS MORE OR LESS.**
